The <u>9th International ASPO Conference</u> will take place in Brussels, Belgium from 27 to 29 April 2011. Based on the theme of "European Energy Policy in an era of expensive energy" <u>ASPO 9</u> will cover a wide range of topics related to fossil fuel depletion. The conference will zoom in on consequences of diminishing oil exports to importing nations, the availability of natural gas, unconventional supplies of oil, gas, and coal, effects of high oil prices on the economy and agriculture, Integrating Renewable Energy Sources into the electricity grid, and European energy policy.
